AnchorShade III - A simple solution to an uncomfortable problem! Lightweight and and versatile, **AnchorShade III** provides comfort for those times when just lounging on your boat is the pleasure of the day. If you're looking for an alternative to the expense and permanence of a custom top and want portable shade, **AnchorShade III** is the answer!

This uniquely designed 6ft. x 6ft. square umbrella can be used on almost any vessel, from a small fishing boat to the larger high performance boats. **AnchorShade III** features a lightweight mildew/fade resistant, water repellant, UV treated nylon top which blocks out 85-90% of harmful rays, adjustable nylon straps, and a pole and frame construction of tempered steel which is phosphate-dipped and powder coated to prevent rusting. **AnchorShade III is designed to be used when anchored or at idle speed on a calm day.** While relaxing on the water, at dockside, or while fishing the streams.

Extremely portable at 10 lbs., **AnchorShade III** goes up in seconds and works by reverse pressure. The pole provides the up pressure (pole cam locks at desired height up to 8') and straps provide the down pressure.

The adjustable strap has a plastic clip hook at one end which hooks to the corner of the cover and a D-ring at the other end which simply slips onto the tip of existing boat cleat. You can also wrap the strap around a handrail so that the D-ring slips into the adjustable strap has a plastic clip hook at one end which hooks to the corner of the cover.

- **ALWAYS** Store Dry.
- **NEVER** Leave Unattended.
- **NEVER** use in winds exceeding 10m/hr.
- **NOT** to be used while boat is underway.



To Remove Cover from Top Pole with the **AnchorShade III** in the closed position, remove the white bell-shaped top cap by twisting and pulling until it pops off. Then gently tug down on each corner of the cover so that each rib comes out of each pocket. Lift the cover up over the top pole.

To Replace Cover On The Top Pole with the **AnchorShade III** in the closed position, drape cover over top pole, placing the metal ring in center of cover over the very top of the pole. Gently place each rib into each pocket of the cover. Replace white bell-shaped top cap.
